## Practice Areas

Lu Jiang is skilled in handling complex disputes over finance, asset management, equity, corporate control, various commercial contracts, etc. She is experienced in representing clients at different levels of PRC courts and arbitration institutions and is quite familiar with asset preservation and enforcement proceedings in China.

The representative dispute cases Lu Jiang has dealt with include:

- Representing shareholders in arbitration concerning an asset management product shortfall supplement agreement involving RMB 1 billion and securing a favorable award;
- Representing a leading central state-owned enterprise in international trade contract arbitration against a foreign counterparty with claims of nearly USD 10 million, and reaching a successful settlement;
