## Practice Areas

Typical cases include representing an American-invested company to declare the claims involving several hundred million dollars in the pre-reorganization of Oceanwide; representing a state-owned company to declare the claims involving several hundred million RMB in the bankruptcy reorganization of Chongqing Iron & Steel; representing a foreign-invested bank in a debt restructuring with its debtor, a local state-owned company and has achieved a restructuring plan involving over ten million dollars; representing a large joint-stock bank to declare the claims involving multibillion RMB in the reorganization proceeding of Yunnan Coal Chemical Industry Group and its affiliated companies. Besides, Lu Jiang has also represented Chinese and foreign shareholders in numerous disputes over compulsory liquidation and dissolution of domestic companies.
