Yuan's practice focuses on representing global and domestic fund sponsors in structuring and forming private investment funds, including private equity and venture capital funds, mezzanine funds, buyout funds, real estate funds, securities funds, funds of funds and special purpose funds. Yuan specializes in structuring flexible and efficient solutions for funds in a complex and fast-changing market environment under increasingly complicated regulatory requirements.
